### **Experience and Qualifications**

I obtained my Certificate of qualification in Social Work in 1985. I completed a Diploma in Management Studies in 1990 and a Postgraduate Diploma in Law/CPE in 1999.

### **Social Care Experience**

I worked in Local Government Statutory Children and Adult Services for 32 years, working my way up to becoming Director of Children and Adult Services in 2008 until December 2015, when I became solely Director of Children's Services, following the separation of the two Statutory roles. I retired from Local Government in summer 2017

Since retiring, I have undertaken a number of discrete pieces of work for a number of Local Authorities involving reviews of services including children with complex needs and audits of quality and practice

Since my retirement I have also provided advice as a Statutory Care Consultant as an Associate of CCMS, this has involved liaison with Local Authorities on behalf of Adults requiring access to and provision of community care services .I have also provided advice and guidance in relation to matters relating to Deprivation of Liberty ( DOLs) and Court of Protection work

I have also recently trained as an Ofsted Additional Inspector and will be undertaking Inspections under the new Inspection of Local Authority Children (ILAC) over the coming year
